
Sarasota County Planning and Development Services Department wants you to know that a property owner near you has applied for Rezone Petition No. 16-15, to rezone approximately 132 acres from OUE-1 (Open Use Estate, 1 unit/5 acres), RSF-1 (Residential, Single-Family, 2.5 units/acre), and RMF-1 (Residential, Multi-Family, 6 units/ acre) to RSF-4/PUD (Residential, Single-Family, 5.5 units/acre/Planned Unit Development) zone district.

The Sarasota County Commission will hold a public hearing beginning at 1:30 p.m., or as soon thereafter as possible on November 22 2016, at the Sarasota County Administration Center, Commission Chamber, 1660 Ringling Blvd., Sarasota, Florida.

All interested parties are invited to appear, be heard, and submit relevant evidence.
