SANDHILL CRANE COLTS SEASON

Two subspecies of Sandhill Crane occur in Florida. The Florida Sandhill Crane population numbers between four and five thousand, are non-migratory year-round breeding residents, and are state protected. They are joined every winter by 25,000 migratory Greater Sandhill Cranes that nest every spring in the Great Lakes region. The picture to the right is of a family of Sandhill Cranes dining along Potter Park Drive. The babies are called "colts" because of their long spindly legs. These majestic birds make their home in our fresh water preservation areas. Please be mindful of these downy Native Floridians as you travel along the picturesque roads of Palmer Ranch!



INTERSECTION SIGNAL RESURFACING

This week's photo is of a Red Bellied Woodpecker seen visiting the grounds of *The Glenridge on Palmer Ranch*

The Red Bellied Woodpecker is primarily a bird of the southeast, where its rolling calls are familiar sounds in swamps and riverside woods. Omnivorous and adaptable, this woodpecker has also adjusted to life in suburbs and city parks, and in recent years it has been expanding its range to the north. Despite the name, the red on the belly is not often visible in the field.

Please accept this as an update to the Honore Ave. / Central Sarasota Pkwy Roundabout project as of 3/20/17:

The County and the Palmer Ranch Holdings, LTD. have cooperatively agreed that construction of a roundabout will increase capacity and promote increased safety for the traveling public. The design and construction of the roundabout at the intersection of Honore Ave. and Central Sarasota Parkway will be managed by Palmer Ranch Holdings, LTD. in coordination with the County. The latest amendment to the agreement with Palmer Ranch Holdings, LTD. reflects this effort. Construction was anticipated to start sometime in 2017 and take about 6 months to complete.

Due to higher than anticipated bid prices, Palmer Ranch Holdings, LTD. met with County staff in February 2017 and requested the County provide up-front funding for this project. Amendment No. 7 to the Road Impact Fee Credit and Property Acquisition Agreement between Sarasota County and Palmer Ranch Holdings, LTD. was executed on March 9, 2016. This agreement provides for Palmer Ranch Holdings, LTD. to complete the design and construction of the Roundabout project with eligible costs to be reimbursed through Road Impact Fee Credits.

After further discussion with the County's legal and financial staff, costs can be fully repaid to the Palmer Ranch Holdings, LTD. through credits/reimbursements in accordance with the current agreement in place. Therefore, advance funding will not be provided.

The recent biennial traffic monitoring report (BTMR) submitted by Palmer Ranch Holdings, LTD. indicates that a traffic signal at the Honore Ave. / Central Sarasota Pkwy Intersection is now warranted. As such a formal notice is being provided to Palmer Ranch Holdings, LTD. Sarasota County Resolution No. 2015-147, which is a supplement to Palmer Ranch's Development of Regional Impact (DRI) Development Order, Section 4.7 states:

4.7 The County shall provide notice that an improvement is needed in the formal review comments for the monitoring report. Upon receipt of the notice that an improvement is needed, the improvement, shall be under binding executed contract for construction within nine months. This deadline may be extended by the Public Works Business Center if this deadline cannot be met due to factors beyond the control of the applicant.

Palmer Ranch Holdings, LTD. has indicated that they will comply with this requirement and still intend to build a roundabout due to the enhanced safety provided versus a traffic signal. However, they do not intend to begin sooner than required. Also, Palmer Ranch Holdings, LTD.'s representative has further indicated their intent is to not start construction of the roundabout until after the end of the tourist season next year (after Easter 2018).

County staff will continue to monitor the intersection and may make other interim modifications to increase intersection safety until such time as the construction of the roundabout begins. Movement restrictions may be considered should conditions warrant.
