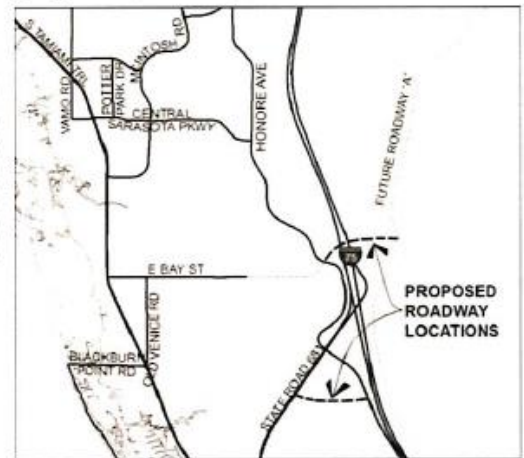
Notice of Public Hearing

Sarasota County Planning and Development Services Department wants you to know about **Comprehensive Plan Amendment No. 2017-A**, a privately-initiated Amendment to the Primary Components of the Comprehensive Plan including Maps 10-8 and 10-9 of the Year 2040 Future Thoroughfare Plan of the Future Land Use Chapter and Table 10-5 of the Transportation Chapter, as they relate to the extension of Bay Street, a four-lane Major Collector Roadway, eastward from Honore Avenue, across Interstate 75 to North-South Roadway A, and the addition of an unnamed two-lane Minor Collector Roadway between S.R. 681 and Honore Avenue.

The **Planning Commission** will hold a **public hearing** beginning at **5:00 p.m.**, or as soon thereafter as possible, on **September 21, 2017**, at the **Sarasota County Administration Center, County Commission Chamber, 1660 Ringling Blvd., Sarasota, Florida.**

All interested parties are invited to appear, be heard, and submit relevant evidence. Copies of the petition and supporting documents are available during normal business hours in the Planning and Development Services Department at 1660 Ringling Blvd., Sarasota, Florida.
