NATIONAL ARBOR DAY- FRIDAY, APRIL 26TH

The first American Arbor Day was originated in Nebraska City, Nebraska by J. Sterling Morton. On April 10, 1872, an estimated one million trees were planted in Nebraska.



Birdsey Northrop of Connecticut was responsible for globalizing the idea when he visited Japan in 1883 and delivered his Arbor Day and Village Improvement message. In that same year, the American Forestry Association made Northrop the Chairman of the committee to campaign for Arbor Day nationwide. He also brought his enthusiasm for Arbor Day to Australia, Canada, and Europe.

Arbor Day is a holiday in which individuals and groups are encouraged to plant trees. Today, many countries observe such a holiday. Though usually observed in the spring, the date varies, depending on climate and suitable planting season.

REMINDER TO PUSH THE BUTTON - CENTRAL SARASOTA PARKWAY AT THE LEGACY TRAIL

Many pedestrians and cyclists are **pushing the button** to activate the flashing lights at the Legacy Trail crossing at Central Sarasota Parkway.



- 1. Push Button to Alert Motorist
- 2. Wait for Vehicle to Stop
- 3. Make eye contact with the driver.
- 4. Cross Carefully



Florida law grants cyclists on the crosswalk the same rights and responsibilities as pedestrians. Drivers are required to yield to pedestrians at the crosswalk. The purpose of the flashing lights is to alert motorists that there is someone entering the crosswalk and they must yield.

USE CAUTION AT CROSSWALKS

With the continued sunny weather, many people are out enjoying the great outdoors, and walking the tree lined sidewalks. Throughout Palmer Ranch, there are designated crosswalks. Some people misunderstand the purpose and meaning of a crosswalk, believing it is the only place pedestrians are *permitted* to cross the street. That is not the case. A crosswalk is where drivers are expected to yield to pedestrians. Drivers approaching crosswalks – either marked or unmarked – must yield to pedestrians who are legally in the crosswalk and approaching closely enough to be in conflict.



Pedestrians cannot enter the crosswalk at any time they wish. One cannot expect a driver to do the impossible, such as coming to a stop from 45 mph in 100 feet. Pedestrians must give drivers adequate time and distance to react and stop.



SANDHILL CRANE COLTS SEASON

Two subspecies of Sandhill Crane occur in Florida. The Florida Sandhill Crane population numbers between four and five thousand, are non-migratory year-round breeding residents, and are state protected. They are joined every winter by 25,000 migratory Greater Sandhill Cranes that nest every spring in the Great Lakes region. The babies are called "colts" because of their long spindly legs. These majestic birds make their home in our freshwater preservation areas. Please be mindful of these downy Native Floridians as you travel along the picturesque roads of Palmer Ranch!

Why Do Members Have to Pay an Annual Assessment to Palmer Ranch Master Association?

Beautification ...More than two-thirds of the nominal \$175 annual Master Association assessment goes towards upkeep and ongoing beautification of Palmer Ranch; for example:

- Over 220 acres of rights-of-way, trimmed on a schedule.
- ❖ Major entry features (community signs, flagpole, lush landscape & lighting).
- ❖ Directional signs, each beautifully landscaped.
- ❖ 15 tons of winter rye seed and 6,000 bags of mulch spread annually.
- ❖ 1,200+ Cabbage Palms trimmed throughout the ranch, on an annual basis.
- ❖ 180+ Crape Myrtle Trees trimmed and shaped each winter.
- ❖ 4,500 annuals at major entrances and directional signs, changed out at least 4 times a year.
- ❖ Park benches throughout the property, providing pleasant places for pedestrians to rest.
- Substantial funds are budgeted each year for further beautifications.

The Palmer Ranch Master Association (PRMA) is pleased to announce that at our Annual Meeting on March 21st, the Master Association Board of Trustees voted in favor of creating a PRMA CERT (Community Emergency Response Team) for the common areas of Palmer Ranch. Dennis Hudson, who was re-elected to our Board of Trustees, graciously accepted the position of PRMA CERT Chairperson and I will be the PRMA CERT Advisor for the Master Association.



This Team will be different than the existing 58 Teams in Sarasota County in that all those Teams are community-based and do not go outside of the community it serves. Our Team will only be servicing the areas outside of the communities on Palmer Ranch. We'll be accepting Team members from any of the communities on Palmer Ranch who want to serve outside of their property lines. The goal of our Team is to ascertain that the roads are clear and safe to drive on.

While we will not be serving individual homes and residents, we do have miles of infrastructure subject to damage and flooding. We also have commercial and recreational properties likewise, subject to damage that we can inspect and report back to the owners (Commercial/Recreational Owners, please feel free to contact us to get on our Inspection list).

We will provide pre- and post-event situational surveillance and reporting directly to Sarasota County EOC, PRMA Board Members and Commercial/Industrial and Recreational Members.

In addition, PRMA CERT will be actively planning joint practice exercises between the HOA CERT Teams to further our skills, share resources, and hone our best practices. To do that, we will organize and host regular educational sessions for CERT leaders and Teams.

We are looking forward to Palmer Ranch CERT Teams becoming cohesive neighbors helping neighbors as an example for other communities.
